Dear Emeriti:

The Emeriti Board has met by Zoom and made initial plans for the Association for Fall semester. We do not feel that any luncheons will be possible. However we hope to provide online opportunities for all Emeriti to meet with each other.

First, the Board plans to send a welcoming letter by US Mail to all emeriti, including our forty-seven new members. The timing of the letter will be determined by when Mail Services is able to produce mailing addresses but we hope the letters will be ready to post in September.

Secondly, we are scheduling a Zoom meeting for all Emeriti on Thursday, Oct 15 at 11am. The September mailing will provide instructions for the meeting. Also planned for this meeting are research presentations by two of the students whose research was supported last year by the Emeriti Association.

Since the April meeting was cancelled because of the pandemic, no action was taken. However, the Nominating has now met electronically and a slate of board members is presented. After discussion, it was moved by Leslie Flemming and seconded by Scott Malcom that: **The Board shall inform the membership of the recommendations of the Nominating Committee; and will recognize this slate of officers until the April meeting of 2021.
